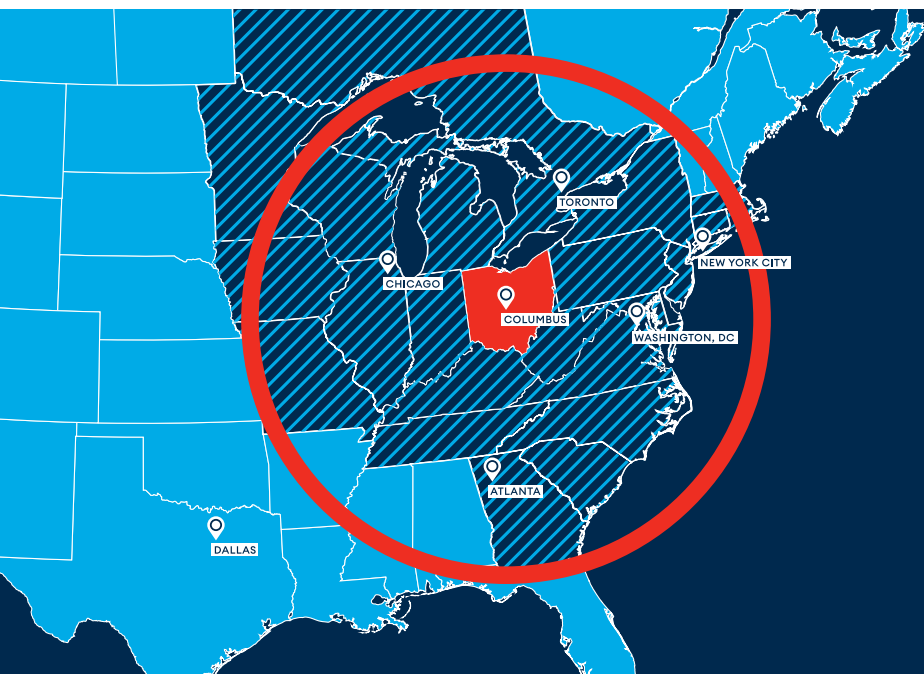
### #2 SITES & INFRASTRUCTURE

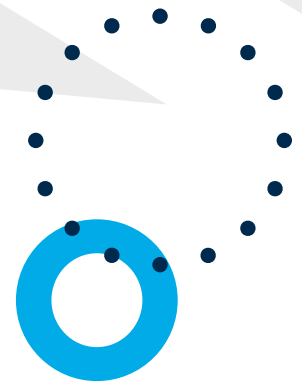
